### **Duluth Airport Authority Board Approves Agreements with Uber and Lyft to operate out of Duluth International Airport**

DULUTH, MN—The [Duluth International Airport \(DLH\)](#) is pleased to announce agreements with Uber and Lyft, permitting the Transportation Network Companies (TNC's) to operate at the airport. The TNC operating agreement was approved at the Airport Authority board meeting on Tuesday, April 18<sup>th</sup>. The action of the Authority followed the approval of the City of Duluth TNC ordinance that was approved and effective April 27<sup>th</sup>. As of this week, both Uber and Lyft organizations signed and returned their operating agreements to the Airport Authority.

Under the agreements, Uber and Lyft and their drivers are authorized to operate at DLH for passenger pick-ups for pre-arranged fares. Passengers can access Uber or Lyft services by opening the ride-sharing app on their phone and choosing a car. The staging lot for the vehicles will be located in our West parking lot adjacent to the arrival end of the passenger terminal. Wayfinding signage is expected to be in place by the end of this month to help direct passengers to the different commercial vehicle options at DLH. All passenger drop-offs will occur curbside in front of the terminal building.

“We are pleased to be able to offer a variety of different transportation options to get our customers to their destination in a safe and reliable manner. We currently have public transportation available through the DTA, taxi service, limousine and shuttle companies, hotel shuttles, car rentals and now Uber and Lyft.
