FAA Airport Terminal Program Overview

- **February 27, 2023** DAA notified of Intent of Funding by FAA
- DAA awarded Federal Grant of \$1,187,000
 Available to cover 95% of costs of eligible project elements
- Project bids and grant paperwork must be submitted to FAA by **July 1, 2023.**

Site Challenges

- Floodplain floor elevation requirement 607.00'
 - Existing apron (604.50')
 - Existing terminal building (605.50')
 - Existing attached Hangar can remain as-is
- Two ADA compliant entrances required
- Traffic flow & parking in-front of building
- Building utilities and adequate spacing

FAA Funding Eligibility


Funding eligibility of each type and size of space is determined by FAA. Examples:

Eligible

- Pilot lounge & briefing
- Restrooms
- Waiting room
- 24/7 public vending
- Fixed furniture

<u>Ineligible</u>

- Meeting rooms
- Office
- Certain revenue generating space
- Patio
- Furniture
- Kitchenette

Interior Building Elements

- Pilot lounge
- Pilot briefing room
- Office (FAA Ineligible cost 100% DAA funding)
- (2) Family Restrooms
- Central Waiting Room w/ Kitchenette Area
- Utility Support Room (Mechanical & Electrical)
- 24/7 Accessible Concession Area
- Drinking Fountains

Note: Funding eligibility of each type and size of space is determined by FAA.


